Bounce House Permit

The following permit when issued to _____, shall permit installation of a
(Name)
temporary bounce house(s) on the City of North Salt Lake facilities. The City of North Salt Lake regulates that bounce houses can only be installed for 12 hours in a 24 hour period. The City of North Salt Lake reserves the right to remove or deny bounce houses for but not limited to the following reasons:

1. Damage to City of North Salt Lake facilities
2. Maintenance
3. Weather
4. Type of apparatus

This permit must remain with responsible party on site at all times apparatus is installed. The undersigned must contact the City of North Salt Lake Parks Department (801-335-8700) **72 hours in advance to discuss bounce house placement.** Bounce houses shall not conflict with above ground or underground facilities. Party acknowledges responsibility to call Blue Stakes 48 hours in advance to have other underground utilities marked prior to staking. Staking of bounce house(s) in paved surfaces shall be prohibited.

Where available the City shall at its own cost and expense supply the User with a reasonable amount of existing utilities, including, water and electricity. The determination of what is reasonable shall be one made solely by the City. Otherwise generators or other utilities must be provided by the undersigned permit holder.

Waiver of indemnification must be signed and submitted to the City of North Salt Lake before bounce house can be utilized.
